FINANCIAL REPORT

CAROLYN CALLAHAN – DIRECTOR, DEPARTMENT OF TEMPORAL AFFAIRS

The full audit report for the Chancery office finances of the Diocese of Jackson are available online at https://jacksondiocese.org/offices/administration-finance/. The pie charts included in this report exclude the restricted net asset and related transactions of the proceeds from the Sarullo Estate bequeathed to the diocese, for the sole use and benefit of St. Joseph Catholic Church and Parish, Greenville, that are a required part of the audited financial statements.

Included in the audited financial statements are the Current Fund and Deposit and Loan Fund. The Current Fund represents the services provided to the parishes, schools, and missions by the diocesan bishop and his representatives including the offices of the Bishop, Vicar General, Chancellor, Archives, Communication, Education, Faith Formation, Liturgy, Seminarian Education and Vocations, Stewardship and Development, and Temporal Affairs. The Deposit and Loan fund represents the savings of all parish and school locations and the related investment portfolio. Separate from this report are the income and expenses of Catholic Charities and the Catholic Foundation.

Two main sources of income for the Chancery office are the annual Cathedraticum assessment and the Catholic Service Appeal. The Cathedraticum assessment is currently 10.5% of the annual parish income less certain exemptions for approved capital campaigns and subsidies paid to schools. Income from this annual assessment funds the expenses of the office of the Bishop and his extended administration, retirement and health insurance costs for all

priests, and seminarian education, stipends, and benefits costs.

Personnel salary and benefits, clergy benefits and assistance, and seminarian education represent the major expenses of the administration of the Bishop. Other routine expenses include workshops and conferences held and attended, travel, newspaper printing and distribution costs, and grants awarded to parishes and schools.

Significant functions and improvements within the Temporal Affairs (finance) office for the last three years include but are not limited to:

- Filing 79 Paycheck Protection Plan applications for all parishes and schools within the diocese for a total of \$5,422,000. These funds were distributed to each specific location to offset their individual payroll costs. PPP loans were fully forgiven except for three locations having a combined PPP total of just under \$6,000. Second round PPP applications were filed for five schools and three parishes.
- Consolidation of the Deposit and Loan investment portfolio to minimize risk, contracting with an experienced investment consultant who provides regular and transparent statements, and quarterly review of the portfolio by a separate investment committee.
- Actively involved Finance Council led by a lay expert Chair, advisory to the bishop, including various active committees such as the budget committee, audit committee, and investment committee.
 - Collaboration with the federal government

to improve overall best practices regarding ethics, communication, and finances of parishes and the chancery office.

- Strong working relationship with independent audit firm and compliance with GAAP.
- Improved internal financial reporting processes and budget planning.
- Streamlining of procedures using external resources to improve internal controls and processes with fewer department employees.
- Strengthened collaboration with Catholic Charities regarding finances.
- Stabilizing of medical premiums and overall health plan costs by working with newly formed Department of Human Resources to change providers.

Plans for the future include but are not limited to:

- Separately incorporating the Deposit and Loan fund to be administered by a board consisting of the bishop and a selection of priests, lay ecclesial ministers, school principals, and lay parishioner experts.
- Review of the current diocesan lay retirement plan.
- Implementation of Internal Audit program for parishes.
- Creation of School Finances Guide to Best Practices


- The Chancellor coordinates archives and records for the Bishop of the Diocese.

- The intricate process for the cause of canonization for Servant of God Sr. Thea Bowman, FSPA, is the responsibility of the Chancellor's office as well.
- Developed and implemented response protocols for all Lighthouse reports
- Assisted in fulfilling compliance requirements for the Deferred Prosecution Agreement with the U.S. Attorney's office
- Facilitated several canonical processes
- Began a digitization project for older annual parish and diocesan reports
- Enrolled in a certificate for records management graduate program to help better organize diocesan data and information
- Mapped out the confirmation schedule in accord with COVID protocols
- Coordinated funeral rites for Bishop Emeritus Joseph N. Latino and Father Brian Kaskie
- Aided with live streaming special events, funerals and Masses with Bishop Kopacz

CATHOLIC EDUCATION EXECUTIVE DIRECTOR OF SCHOOL OPERATIONS KARLA LUKE

- Catherine Cook retired after almost three decades of outstanding service to the Office of Catholic Education in the Diocese of Jackson
- Bishop Kopacz approved the restructuring of the Office of Catholic Education encompassing the positions of Executive Director of School Operations and Director of Curriculum and Development.
- Closing of Holy Family Early Learning Center in Natchez
- Opened the Sisters of Mercy Early Learning Center in Vicksburg welcoming Katie Emfinger as the center director
- Welcomed two new administrators to the Office of Catholic Education: Jessica Carter, Principal and Lead Administrator at Cathedral Catholic School in Natchez and Will Vollor, Principal of St. Patrick School in Meridian.

- Completed 34,668 service hours or an average of 201 per graduate

STEWARDSHIP AND DEVELOPMENT

DIRECTOR REBECCA HARRIS

Stewardship Office

- Launched the Stewardship Paths monthly newsletter through Flocknote to provide parishes with stewardship materials that can be shared with parishioners. It includes weekly readings, reflections and other materials on time, talent and generosity.
- Aided the vocations office on the 2nd annual Homegrown Harvest which raised \$84,500.
- Worked with parishes to write Catholic Extension grants which funded over \$221,000.

Catholic Service Appeal

- Catholic Service Appeal raised \$1,066,000 with 2,295 donors. The average gift was \$464.53. The goal for the 2022 Catholic Service Appeal was \$1,153,654. Due to the pandemic the goal was not reached but the generosity of those who could give helped fund the 11 ministries served by the appeal.
- Catholic Charities provides social services around the state with offices in Jackson, Natchez and Vardaman. They offer adoption, mental health services, migrant services, domestic violence services and much more. Catholic Charities received \$300,329 which is 31.57%.
- Formational Ministry offices work to bring people into a closer relationship with God through religious education, family ministry, intercultural ministry and youth ministry which received a total of \$150,500 which is 15%.
- Religious Education and Faith Formational Office received \$40,000
- Family Ministry received \$35,500
- Intercultural Ministries received \$40,000
- Youth Ministry received \$35,500
- Campus Ministry provides young adults in college a way to connect and grow their faith, which received \$50,000 which is 5%.
- Parishes and Schools receive support through a grant process to help with projects and outreach and received \$75,000 which is 8%.
- Retired Priests and Clergy Assistance continue to serve our diocese. Currently, we have 21 retired priests in our diocese and received \$175,000 which is 18%.
- The CSA provides our six seminarians in formation to the priesthood, which received \$150,000 which is 16%.

Catholic Foundation

- There were 13 new trusts established with the Catholic Foundation. The Foundation celebrated 48 years and the investments reached \$58M.
- The Foundation distributed 7.5% to trust beneficiaries and distributed \$98,000 to 22 grant
- The Foundation had 811 members and raised over \$99,000 for membership. This helps the operations of the Foundation office so that management fees are not charged to each trust.

FAITH FORMATION

DIRECTOR FRAN LAVELLE

Office of Family Ministry

- The Knights of Columbus Ultrasound Initiative remains a vital ministry. The Tupelo Knights of Columbus Council were given approval by the Fraternal Mission to move forward to the next step of the Initiative.
- The Office is partnering with "Her PLAN (Her Pregnancy and Life Assistance Network)" to create a website that is a comprehensive directory of services supporting pregnant and parenting women throughout the diocese.
- Engaged Encounter weekends were resumed in October 2021 after being suspended due to the pandemic.

Office of Intercultural Ministry

- Led workshops on the pastoral letter on racism "Open Wide Our Hearts" to groups that ranged in age and backgrounds in Tupelo, Yazoo City, and Greenwood
- Led bilingual presentations: on Evangelization and Confirmation
- Spoke at several parishes including Camden, Canton, Yazoo City, Booneville, Ripley, Pearl, among others, which included celebrating the Mass and introducing the mission and vision of the OIM to get to know the parishes in the diocese
- Celebrated diversity and encouraged people by promoting their cultural heritage and celebrated Ripley's bilingual feast of their patron saint and Our Lady of Guadalupe in Pontotoc and Jackson
 Led the Spanish LIMEX Retreat at Tupelo

Office of Religious Education & Faith Formation

- In person ministry resumed with the return of the Pastoral Ministry Workshop, a formation program for lay leaders
- Increased number of Catechists certification in both Level I and Level II
- Resumed presenting in-person retreats

Office of Youth Ministry

- Accommodated and safely sponsored two annual youth events the July Search Retreat for juniors and seniors and a Middle School Fall Retreat for seventh and eighth graders.
- Introduced a new training program for youth ministers called "First Things in Youth Ministry." The program is sponsored by the National Federation for Catholic Youth Ministry.
- Launched a new digital permission form platform, PermissionClick, for any parish in the diocese. The platform allows parishes to send and receive digital permission forms and collect electronic signatures from parents for youth events, trips and service projects.
- Abbey Schuhmann, coordinator for the OYM was elected to serve on the Board of Directors for the National Federation for Catholic Youth Ministry in the U.S.



Vocations Director Father Nick Adam

- The Department of Vocations hosted two major discernment retreats for young men who are open to the possibility of a call to priesthood. These two *Quo Vadis?* retreats were modeled on events held in other dioceses but were the first to be offered in the Diocese of Jackson. Approximately 25 young men attended these retreats free of charge.
- Hosted three discerners at Notre Dame Seminary and St. Joseph Seminary College for a more focused visit to see what seminary life is like. One young woman visited a religious community during this calendar year.
- Father Nick visited approximately 25 parish communities and missions, with visits consisting of weekend masses, youth group talks, and other activities. He also visited several diocesan schools throughout the year, celebrating school Mass or hosting other activities to promote vocations. All of his travel was supported through the vocations budget.
- We have six seminarians studying for the diocese with no new seminarians beginning formation this calendar year. Deacon Andrew Bowden was ordained a transitional deacon at St. Jude in Pearl in May 2021. He will be ordained a priest May 14, 2022.
- One woman from our diocese entered religious life, as Kathleen McMullin is now in Postulancy with the Sisters of St. Francis of the Martyr St. George in Alton, Illinois. While our annual budget along with Catholic Service Appeal allotment pays for all tuition, books and fees for our seminarians as well as our promotional efforts for diocesan priesthood, we also seek to support candidates for religious life as they continue to discern their vocation, but their chosen order pays their tuition/room/board/etc. once they enter into postulancy or the novitiate.
- Held the 2nd Annual Homegrown Harvest Festival at St. Paul Flowood. Proceeds went to support promotional programs, trips, retreats, support services for discerners, as well as seminarian education.

PERMANENT DIACONATE AND HUMAN RESOURCES

Director Deacon John McGregor

- Six men have begun their final year of formation for the Permanent Diaconate. They are scheduled to be ordained on July 16, 2022.
- Eight men have been accepted into Aspirancy for the Permanent Diaconate. Aspirancy is the year of prayer and discernment before they begin the four-year formation program.
- Developed a new section of the Chancery Personnel Handbook, which eliminated previous ambiguities and abandoned practices.
- Hired Jenifer Jenkins to replace Vickie Carollo after her retirement. Jenifer is making great progress with getting people "back on track" with Virtus and Protection of Children and Vulnerable Adults training, following the COVID shutdowns




Communications Director Joanna Puddister King

- Worked with Bishop Kopacz on videos touching on various Catholic events, holy days and Catholic social teaching topics.


